WHAT: Live Music, Oysters, BBQ, Beer, Wine and Soft Drinks

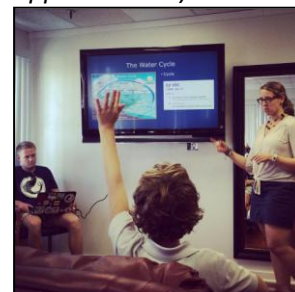
